Besides a number of medium scale sub-divisions that are already in progress, two new ones have received conditional approval in the last few months. Both of these new developers have indicated they are supportive of the town's policies as laid out in the draft Municipal Plan.

Work is in progress that will see the large welcoming signs to the Town refurbished with the new logo and most of the remaining street signs will be replaced with the new models during the summer. In addition we hope to have a number of Heritage signs put in place giving tourists and residents, alike, little pieces of our Town history.

We are currently waiting for confirmation from the province with respect to any regulation that we must meet in order to proceed with the next phase of pursuing a wind-power development project. If successful, this project will save the town significant dollars annually over the long term.

The Town recently tendered for a new piece of snowclearing equipment. Included in the specification is the request for side guards. Side guards are innovative safety device to prevent people from sliding under heavy class vehicles such as snow clearing equipment. The spec was designed by an engineer from the community.

While sometimes the news media and some government officials have not been very complimentary, your Council, is moving ahead with innovative plans and improvements. I welcome your comments and questions.

The Town of Portugal Cove-St. Philip's becomes first in Canada to require side guards on new trucks

On March 10th, 2009, Council voted to include an 'underguard/sideguard' component in the new Plow Truck Tender Specification.

The Town recently called tenders for a new Dump Truck to be used in snow clearing operations. The tender called for the installation of side guards before the delivery of the new vehicle. The Guards are designed to help prevent injury or deaths by stopping pedestrians and bikers from being dragged under the wheels of such heavy equipment.

The action comes in the wake of a tragic death of a young woman in Montreal with ties to the Community. Jessica Lauren Holman-Price was accidentally killed while successfully preventing her ten year old brother from being dragged under the wheels of a piece of snow clearing equipment on a busy Montreal intersection. This tragic death may have been prevented if the truck had been equipped with side guards.

The Town of Portugal Cove-St. Philip's hopes that this will set a precedent across Canada and help prevent many unnecessary injuries and deaths. Mayor Norm Collins says he hopes that Municipalities and all levels of Government across the Province and Country will take similar action to prevent such tragedies in the future.

Collins says, "This may force Transport Canada into changing the rules and requiring all vehicles of a certain type to be equipped with this safety mechanism". The side guards are mandatory in Great Britain and other European countries.

## **Boaters and Jet Ski Operators Card**

As of September 15, 2009, everybody who operates jet skis or a boat that has a motor must, by federal law, obtain a Pleasure Craft Operator Card (PCOC). This includes large and small power boats, sailboats, and small open boats with outboard motors. It's the same as a driver's license for a car, and people operating a boat without this card will be subject to a fine. It doesn't matter whether you're operating your boat on the ocean or on a pond, everybody still has to have this card.

Boaters and jet ski operators: Get your mandatory Pleasure Craft Operator Card for \$65 by calling 895-3137.

### **Town Signs Missing**

The Town has been experiencing difficulty in keeping street signs posted. Over the past couple of years there have been several street signs removed from there post by vandals. This practice creates two problems.

**Emergencies:** Too many times when emergency equipment is called to a residence the difference between life and death is minutes. Imagine having called an ambulance only to find that they cannot find your road because the sign was missing. This is valuable time wasted!

**Cost:** The cost initially associated with erecting a sign is approximately \$400. This includes labor and materials. Just to replace a missing sign and bracket is approximately \$150. Coupled with that is man hours and tools needed to complete the job. Not an inexpensive endeavor.

The Town is requesting any person that has any information concerning the missing signs and or the location of any of the Town signs to please call the Town Office and leave the information. Also if any person or persons have any sings in there possession to please return the sign to the Town Office or either of the Fire Departments. In either case there will be no questions asked. If the Town has reason to believe any person is in possession of a Town sign the police will be contacted and charges will be laid.
