Town takes over maintenance of nine provincial roads within the town.

After lengthy negotiation with the Department of Works and Services, Mayor Norm Collins is pleased to announce the Town will be taking over maintenance of nine roads within the town. This includes snow clearing services, something the town is better able to provide. Part of the settlement is a payment from the department to cover the maintenance costs for a ten year period. In addition, the department has committed to upgrading the roads to town standards over the next three years. New pavement is part of that upgrading, and the town will be consulted for a schedule of the work.

Councillor Jon Seary, Chair of Public Works, is pleased with the successful outcome. "This is a good deal for our town, as it recognizes the Town can provide these services more effectively than what is done now, while allowing an arrangement to cover the cost. This work will be done by Town employees, who are residents themselves."

Town Announces Tax Exemption for New Business

The Town of Portugal Cove-St. Philips revised the policy for granting tax exemptions for new businesses. A tax holiday of one year from the date the business permit is granted will now apply.

Deputy Mayor Keith Mercer, Chair of the Executive Committee, says this is a positive step forward to entice new business to the community. "New business in the town can increase employment to the residents, provide more locally available services, and benefit the town as a whole"

The policy is retroactive to all businesses who received permits as of July 1, 2006.

Planning & Development

After a year and a half as Chair of the Planning and Development committee, Councillor Steve Andrews shares some food for thought for anyone considering a development application for a single family dwelling or significant renovation of an existing dwelling.

First: Contact the Town

From time to time, residents planning to build or develop a property contact councilors to see if their plans have a chance of getting approved. While councilors welcome the consultation with you, the staff has more technical knowledge of town policies and regulations and the past history of interpretation of the wording of these items.

If no obvious alternatives exist that are acceptable to you, then you generally have two options. One is to submit a revised application with the associated fees. The other option is to appeal the decision of council to the Eastern Regional Appeals Board. This is a time-limited option, where you have 14 days from the time you are notified of

Your first step should be contacting a member of the Planning & Development office to obtain a copy of the detailed steps to follow. If you actually need to meet with someone, please call ahead to set a time since scheduling is very important with our small staff.

Second: Submit your application

The next step is to submit your application providing all the necessary supporting documents. If your application is straight forward, in that its fits within the current regulations, the processing will usually be handled without involving councilors. If your application requires a variance from the current standards, fits into a category where the policies or regulations permit council discretion or falls outside the framework of the current town plan, then the application is generally sent to the Planning and Development Committee for consideration and they may consider a recommendation to council.

Once council makes a decision at a public council meeting, you will usually be advised within two weeks

following the meeting. If your application is approved and you are satisfied with the attached conditions, then you can proceed to acquire the various permits.

Third: Recourse

If your application is rejected or you are not satisfied with the attached conditions, you can first contact the Planning and Development office to see it they can suggest any alternative approaches under the current plan.

If no obvious alternatives exist that are acceptable to you, then you generally have two options. One is to submit a revised application with the associated fees. The other option is to appeal the decision of council to the Eastern Regional Appeals Board. This is a time-limited option, where you have 14 days from the time you are notified of council's decision to submit your appeal. The Planning & Development office will be happy to provide you with the contact information needed to submit your appeal. There is a fee which you will get back only if your appeal is successful. Since the fee refund comes from the town and not the Appeals Board, the Planning and Development Committee does its best not to make recommendations that risk being overturned.

Summary

As you can see (and this becomes even more obvious when you see the complete process), the whole effort can take some time, particularly if you end up going to the Appeals Board. Therefore, to avoid frustration as the applicant, don't leave starting the process to the last minute.

In the next issue of our Newsletter we will look at some specific regulations and how they are interpreted for an application.
