#### **Planning & Development**

#### Municipal Plan Policies versus Regulations

Councillor Steve Andrews continues his articles about our Town's Planning and Development.

One thing that sometimes confuses individuals who make application to the town for a development is the matter of a policy versus a regulation. Since regulation tend to be more specific, applicants tend to read these first and can sometimes be surprised to find that what they thought could be done, can't.

The policies of the Municipal Plan are the overriding rules that must be adhered to and when you make application, it is important that you read the relevant policies and discuss them with the Planning & Development staff before proceeding too far. Once you understand the policy then you need to review the specific regulations that relate to your particular application. Those will be in two places. There are general regulations that apply to all categories of land (commonly referred to as land use zones) within the community. Then there are specific regulations that apply only to your specific land use zone. (Is all the land in the community placed in a specific category? The answer is YES.)

Since no Municipal Plan is perfect, there will be some occasions where there will be a conflict between policies and regulations. In such cases council is empowered to rule on how the matter will be settled. In most instances council will adhere to the policy and either override or correct a conflicting regulation. If no policy or regulation exists for the specific type of development then the applicant or council may pursue having them developed with the use of the town's Planning Consultants. A recent example of these actions involved the adoption of a policy and regulation with regard to private wind turbines and in another case the regulations for large serviced lots with pond frontage.



It should be noted that such changes to policy and regulations can be expensive and time consuming and are subject to public scrutiny through newspaper notices and public hearings.

In summary, before you make an application for development or to set up a business, be sure to read and understand the relevant policies and then the related regulations and discuss any concerns with Planning & Development staff before submitting your application.

As many of you will be aware, our Municipal Plan is now under review and it is anticipated that a number of policies and regulations will be updated. SO if you have particular concerns or just want to see that your town plan is clear and concise with a minimum of ambiguity, then keep your eyes and ears open for announcements on the public meetings that will be held sometime in May 2007.
