Census 2006

Count yourself in to help out our community

As many of you may have already heard, May 16, 2006 is Census Day. It is that one day every five years when every household has the opportunity to be counted in.

The result will be that all of us, including writers, researchers, entrepreneurs, policy makers, business owners and governments, will have access to a wide variety of data on the current population of Canada. The country and the community develop and grow with the aid of this information.

The success of the census depends on the participation of everyone in Canada and from your perspective, everyone in the Town of Portugal Cove-St. Philip's.

How does it help from a local perspective?

As a very current example information from the census is forming part of the analysis your council is doing in developing a policy for a seniors rebate with respect to property tax.

Other examples include use of the data: by the School Board to determine the needs for the local school and the building of other schools; by the provincial Government to provide funding for infrastructure such as sewage treatment plants and road upgrading and by town councils to aid in determining the appropriate land use zoning for the development of the community.

The bottom line is that council would like this town to get the most it can from the census. To do so, we ask that everyone complete their census form and submit them by mail or via the web on Census Day – May 16, 2006.

We want to give you a further example of the type of information that is generated from the census.

To do this the town will be circulating through the mail a small brochure provided by Stats Canada entitled "Canada at a Glance". This should arrive in you mail box within a few days of this special newsletter.

Finally, if within a few days of May 16th, you have not received your census form simply call 1-800-263-1136 or log on to www.census2006.ca .

Remember, in a census, everybody counts!

Municipal plan to be reviewed

Residents urged to participate

Residents of Portugal Cove-St. Philip's please note that your Town Council is about to begin a community planning process that will result in the preparation of a new municipal plan. In the coming weeks, Council will engage the services of a planning consulting firm to manage the planning process, which is expected to take nearly one year to complete.

As most of you are aware, the Town is experiencing significant growth, particularly in the residential housing sector. In the past six years, the Town issued 433 building permits for single-family dwellings. During the same period, applications have been made for 14 residential subdivisions. Six of these have been approved, resulting in approximately 200 additional building lots.

The rapid pace of new development is transforming our Town, and the accompanying impact upon our community is proving to be a great challenge. A myriad of questions arise about how to plan for and serve everyone's needs. For example, what factors make our community pleasant and efficient? How do we address quality of life issues in terms of the services and facilities that we rely upon and enjoy? What are our priorities with respect to recreation facilities and services, our school, the local street networks, water and sewer infrastructure, economic development, and our natural, cultural and historic resources? How do we sustain essential services, and plan for future growth, without destroying our past or our natural environment? The municipal plan is a key component to managing change. It helps set direction on what matters most to residents, resulting in a more workable, livable, prosperous and efficient community.

The municipal planning process that Council is proposing will be developed from the ground up with detailed research, broad-based community consultation, reasoned analysis and recommendations. Various research techniques will be incorporated to gather information; including a number of focus group and public consultation meetings that are planned throughout the community in a neighborhood near you, a true "grass roots" process. Specifically five or six geographical areas will be identified and the residents from these areas will be invited to participate in determining the way that area of the community will develop over the next ten years. Of equal importance will be another half dozen meetings that will

involve residents interested in specific focus topics such as Business Development, Heritage Conservation and a number of others.

Below is a brief list of some issues to be considered during the consultation process:

- The compatibility of land use within residential areas
- Identification of land for commercial purposes
- Preservation of agricultural land, and resolution of conflicts with encroaching development
- Protected watershed boundaries and associated conflicts
- Conservation and environmental protection of sensitive and scenic areas
- Measures to protect and enhance natural and historic resources

In order to seek out and understand the diverse voices of our community, Council encourage all residents to participate in this important consultation process. While council will suggest it vision as to where we would like to be in 10 years, it is ultimately up to the community as to the direction that should and will be taken. Council looks forward to hearing your views as this process unfolds over the next few months. The Town's website will provide more information on how you can participate in this endeavor.

The Minor Soccer Program has generated a lot of interest and we can ensure that it will be a great success. • Responsibilities:


