Planning & Development Report - January 19th - presented by Councillor Collins

1. 6, 8 and 10 Kittiwake Place

Recreation & Community Services Committee - January 18th presented by Councillor Bartlett

1. Mayors Meeting – January 14th

As requested by the Mayor, the Recreation Director attended a Killick Coast Region Mayor Meeting on Thursday, January 14th for two items on their agenda:

- (a) **Room For One** "Room for One" is a volunteer group fund-raising to sponsor a refugee family to live in Newfoundland. This organization, with Mr. Mike Dwyer and Mr. Mike Whalen as their chairpersons, has requested the assistance of the Mayors by way of seeking support by their respective councils. The Recreation Director will set up a meeting between the group and Council as well as a public meeting to further along "Rooms for One" efforts.
- **(b)** Jack Byrne Arena Member of Jack Byrne Arena presented the future plans for the facility. Recreation Committee discussed the plan for information purposes.

2. Winter Carnival

The Programs and Special Events Coordinator has finalized the schedule of events for the 2016 Winter Carnival. Booklets will be distributed to all residents and advertisements will be placed in the local paper, website, and on social media. The Recreation Department is very pleased with the response from partners and sponsors for the week-long event. Attached is the rough schedule of activities and the booklets will be available by January 29th. We look forward to seeing residents coming out and taking part!

3. Reason for the Rink

As a Winter Carnival event, the Town has partnered with the other Killick Coast Communities, as well as the Town of Paradise for the "Community Challenge Cup". This event is hosted by the "Reason for the Rink" owner, Mr. Todd Churchill of Portugal Cove-St. Philip's. Council members from our community along with Council members from Torbay, Flatrock, Pouch Cove, Bauline, and the MHAs for the region will all in be attendance. 4. RNL – Recreation and Sport for Persons with Disabilities

The Recreation Director was invited to represent the Community Recreation Leaders by participating in the first Annual Stakeholder Meeting initiated by the Recreation and Sport for Persons with a Disability Initiative Steering Committee. This initiative aims to increase support, remove barriers and develop actions to support individuals who wish to participate and engage in recreation and sport activities and to meet the needs of those athletes training and participating in competitive events. This event took place on Thursday, January 21st at St. John's Holiday Inn. The Recreation Director will continue to work with this initiative as she develops an Inclusion Policy for the Town.

5. Baby Sitting Course

The Recreation Department will be hosting its second Baby Sitting Certification Course on Saturday, January 23th. Registration for this course has been filled. We look forward to offering our next Community Service Seminar in February, Heart Healthy Eating Seminar on Tuesday, February 23rd from 6:30p.m. – 8:30p.m. at Rainbow Gully. Registration opens February 1st. Full details of the seminar are available on our website and facebook page.

6. Merry and Bright Festival of Lights

The Recreation Department were very delighted to get the opportunity to travel throughout the community on Wednesday, December 16th and view all the Christmas Decorations the residents had taken the time and effort to display. (See Presentations earlier in Council Meeting for list of winners.)

Public Works Committee – January 20th presented by Councillor Bartlett

1. Snow Clearing

Snow clearing operations were discussed, particularly as it related to two complaints received. Current level of service was discussed and Committee was satisfied with the approach being taken.

2. Connectivity Plan - Update

Staff provided Committee with an update on the connectivity plan for Thorburn Road to Dogberry Hill Road. Work has begun on the options review and quotes for survey work are expected to be received at the end of January 2016. The actual carrying out of the survey work is weather dependent. It is expected that the recommendation from Phase 1 will be presented the end of first quarter/beginning of second quarter 2016.

Economic Development, Marketing & Communications Report - no meeting held/no report

Protective Services Committee – January 19th presented by Councillor Hanlon

1. FES Updates

- There has been a good response to the recent recruitment drive, the chiefs have received applications. One on one interviews start this week.
- The 2016 Training Program has been mapped out through the end of July. Regular members train on Monday nights and new recruits will train on Tuesday nights. The new recruits will train separately for the next four and a half months and if all goes well, the chiefs will begin integration (of the new recruits into the regular membership). The chiefs have begun a new model for training, encouraging members to make presentations in their area of expertise and to assist with training all members.

2. Fireworks Bylaws

The Committee reviewed some concerns around the discharge of family fireworks and discussed the provincial regulations. The Committee agreed that the Town will continue to follow the provincial regulations as all other municipalities in the area have done. The Town will develop a set of safety guidelines and important information, similar to those developed in surrounding municipalities.

3. Safety Vests for Hiking/Walking Club

Council has approved the addition of 50 vests to the reorder of vests for the SafePCSP community group, to be provided to the PCSP Hiking/Walking Club. These vests will contain the Town logo as well as the logo for both community groups.

Civics # 6, 8 & 10 Kittiwake Place Subdivide Property Zoning: Residential Low Density (RLD) - Semi-Serviced

The Committee recommends that the application for Civics # 6, 8 & 10 Kittiwake Place be granted approval in principle, permitting the subdivision of property to create one additional vacant lot. Approval in principle is in accordance with General Regulation 11 (Variances) and 12 (Notice of Variance) which permits a 10.0 % variance on the minimum lot area requirement which will result in a lot area of 7,200 m² as opposed to the minimum of 8,000 m². Approval in principle shall be in full compliance with the Town's Municipal Plan & Development Regulations and all other regulatory bodies of government, specifically, Development Regulation 11 (Variances), Development Regulation 12 (Notice of Variance) and Schedule C: Residential Low Density.
