#### **DELEGATIONS/PRESENTATIONS**

Ronnie O'Neil and Matt Nippard of Choice for Youth made a presentation to the Town in the amount of \$500 for the community JumpStart Program. Choice for Youth, along with Key Assets, Blue Sky, Treatment Centre, Child and Youth Care students from Eastern College, and Waypoints, organized a Softball Tournament on Voisey's Brook Softball Field and received a grant from the Town to offset the

cost of the rental of the facility. Choices for Youth would like to return the favor back to our community by making this donation.

Deputy Mayor Will asked for a description of the JumpStart Program and it was provided by the Director of Recreation and Community Services. A member of the gallery asked if the Town also donated to JumpStart and the Director of Recreation noted that the Town subsidizes applicants as needed for Recreation programs so that every child has an equal opportunity to participate.

#### Recreation & Community Services Committee Report – presented by Councillor Bartlett

#### 1. Presentation from Choices for Youth

On July 8<sup>th</sup> and 9<sup>th</sup> Choices for Youth organized a Softball Tournament on Voisey's Brook Softball Field. This group received a grant from the Town to offset the cost of the rental of the facility. The Recreation Committee is very pleased to announce that Choices for Youth would like to return the favor back to our community by making a donation of \$500.00 to the community JumpStart Program.

#### 2. Bill Churchill Memorial Tournament

The Recreation Director contacted Mr. Craig Churchill, son of Mr. Bill Churchill, to discuss the option to rename the Voisey's Brook Softball Field after his late father. Craig Churchill was very happy with the Town's offer. After much discussion, the committee would like to put forward the following recommendation:

## 4. Rainbow Gully Artificial Turf Expansion

The Recreation Committee discussed the next steps if the Town proceeds with the proposal from ACOA for funding of the Rainbow Gully Artificial Turf Expansion. Staff will provide updated project cost for both options; expansion for soccer and expansion for football. Committee members feel that updated figures will give Council a clearer vision on what direction they would like to pursue. Please find attached support letters from PCSP Minor Soccer and Football NL to expand the field. Note that staff will confirm the field sizes and configurations provided by the organizations and ensure the project cost fits those needs.

## **Public Works Committee Report - presented by Councillor Bartlett**

No meeting was held but the Committee wishes to provide the following information.

### 1. Ditching

As part of the 2016 Maintenance Schedule, Public Works has assessed various ditches within the Town and have dedicated a crew to conduct extensive ditching during this season. This work will be conducted, but is not limited to, the following areas:

Ditching commenced in June and will run through to September.

## 2. Asphalt Repair & Patching

Tender package for the 2016 Asphalt Repair & Patching was advertised in the Telegram, July 23, and is now available to potential bidders with a closing date of August 5<sup>th</sup> at 3:00pm. The Site Locations and Drawings are contained within the tender package, Appendix B.

#### 3. Hydrant Maintenance

Maintenance has begun on the Towns hydrants which may include dismantling for internal inspection; ensuring all aspects of the hydrant are in proper operational condition; replacing any components as needed; and flushing through the hydrants to remove any dirt or debris that may have settled. Identifying labels (numbers) will also be installed on the hydrants this year.

#### 4. Recreation Center – Sewer Tie In

During the week of August 18 through 26<sup>th</sup>, Public Works will be decommissioning the existing septic system for the Recreation Center and connecting to the Town's main sewer line. This

existing septic system has deteriorated with age and it is more cost efficient to connect to the Town's infrastructure rather than replace or repair it.

## <u>Economic Development, Marketing & Communications Report for July 20, 2016 – presented by</u> Councilor Bartlett

## 1. Newbury Street re Traffic

We will be providing residents of Newbury Street a copy of the traffic report that was produced by our traffic consultants. We will then look for input on the report and their thoughts via email or phone. Council and Public Works will then be able to make an informed decision on the area and set a public meeting in late August/early September to outline the plan of action.

## 2. Business Letter of Support

The Committee reviewed a request for a letter of support to a local resident regarding a potential business. They are looking for funding through CBDC for a quilting shop and tea room. The Director of Economic Development will provide a general letter of support. The business will still have to go through the normal process with Planning and Development before being approved to open.

#### 3. Water Metering

The water metering rate report has been reviewed by management. Some edits are currently being made and it will be submitted to council within the next week for review. The public meeting is still scheduled for August 10<sup>th</sup>.

## 4. Demographics and Stats

We are in receipt of the results of the regional survey. The results are in raw form and our Communications Coordinator is currently putting it into an appropriate and easy to read format that we can use for both information and marketing.

#### 5. Mass Notifications Service - Communications

A new communications tool was presented to the committee. It has been reviewed by senior staff and departments. The system will be able to provide us with ability to mass text, call or email residents the way they want to be contacted. It will also be able customize information to residents and be used on mobile devices. The system is currently being used by Torbay, Mount Pearl and CBS. A summary of the company and features are attached. It is an annual fee that can be cancelled any time with no penalty. The cost can fit into the communications budget for 2016.

System at a cost of \$6950 US (this includes set-up fees).

Clarification was made as to the method of gathering the contacts in order to optimize the usage of this system. The Director of Economic Development noted that white pages, in addition to Townsuite and eServices will be initially utilized with a marketing campaign to begin in the new year. The suggestion was made to also utilize the tax bills sent out in January as a place to start. Councilor Hanlon made mention of his positive experience with this system and that it would be a very good fit with the Town's Emergency Management Plan and Business Continuity Plan.

#### 6. Tickle Swim

The Tickle Swim will take place on Tuesday, August 16<sup>th</sup>. As we have in the past we will provide food and refreshments for the reception that will be held following the swim.

#### 3. Loop Drive Concerns

The signage for ferry traffic has been damaged and is in the process of being replaced. The Town's Municipal Liaison for the RNC encourages residents to please call them with reports of traffic and parking concerns so they can allocate their resources to those issues. The more reports the RNC receives the more resources they can send out to the area. The RNC non-emergency number is 729-8000.

#### 4. Skinners Road Safety Concerns

The Committee reviewed a letter from a resident concerned with speeding vehicles and street lights on Skinners Road. This concern will be utilized as part of the annual review of streets through the Town's Speed Limit Policy. Staff will prepare a response to the resident. These concerns will also be passed on to the RNC and once again, residents are asked to call the RNC with reports of any suspicious activity. Staff will follow up with investigating the street lights on Skinners Road.

#### 3. Multi-Year Capital Works

The Town Manager advised that Spurrells Road Bridge and Nearys Pond Road are expected to be completed this construction season and Meadow Heights will likely be done next season. He will contact the engineers to ask if whether during the design stage of Nearys Pond Road work they could consider what the cost and project implications would be in eliminating the ditches to provide wider road shoulders where possible for safer walking.

## 4. Report of ATIPP Activity

As requested by Committee on June 21, a report of ATIPP activity back to October 2013 was prepared and circulated to committee for review. The tabled report (which has been redacted of personal information) provides dates and the wording of the 70 requests received during that time frame. It also notes that in 2013 there were 3 requests October to December 2013, 4 requests in 2014, 32 in 2015 and 31 requests received for 2016 as of July 6<sup>th</sup> when the report was prepared.

Committee agreed that this item will be considered at a future Committee of the Whole meeting after staff meets on July 20<sup>th</sup> with representatives of the Office of the Information and Privacy Commissioner. The scheduled meeting is being held to discuss processes used in responding to requests and may provide additional information helpful to Council's review.

The Committee recommends that the application to construct a subsidiary apartment at Civic # 4 Western Heights be rejected as the proposal does not comply with the Town's Municipal Plan and Development Regulations as the floor area of the proposed subsidiary apartment does not comply with Plan Policy RES-1 (Land Uses) and Schedule C: Residential Medium Density, and there has been no correspondence from the applicant containing information required for a decision within eight weeks as per Development Regulation 19 (2) (Deferment of Application).

The Administrator recommended that this application be rejected.

Item # 2: Civic # 1553-1555 Thorburn Road Dwelling Extension Zoning: Traditional Community (TC) – Serviced

The Committee recommends that the application for Civic # 1553-1555 Thorburn Road be granted approval in principle, permitting the construction of a dwelling extension.

The Administrator recommended that this application be rejected as it does not comply with the Town's Municipal Plan & Development Regulations, specifically Development Regulation 49 (3e) (Non-Conforming Use) as all dwelling extensions on the property will total greater than 50% of the footprint size of the dwelling existing at the time the Town's previous Municipal Plan & Development Regulations came into effect.
