1. Town Managers Report

a) Town Manager was out of town for the past 2 weeks attending the Canadian Association Municipal Administrators and Provincial Professional Municipal Administrators conferences. The limited time spent in the office in between those conferences has been primarily spent addressing concerns of sub-divisions being completed. I am trying my best to get to your concerns in those subdivisions and should be hearing from me soon.

- b) I've been heavily involved in the hiring of a new Director for Public Works. We expect to have our second round of interviews vary shortly, hopefully before the end of this week.
- c) At the PMA Conference, I was elected as the Avalon Director on our Board and in this role I will be representing the interest of all my peers in the Avalon Region. This is a two year term.

2. Conflict of Interest decision request as presented by Deputy Mayor Laham

Councillor Harding works at Murray's Pond Country Club and there will be times when a member of the Club will be involved with a motion before Council. Just to name a few examples: The member could request a permit, or live on a street that will be paved, or may become a member of an advisory committee, etc.

Councillor Harding is unclear and therefore asking Council to decide if voting on such matters puts him in a perceived Conflict of Interest merely because the person involved has a membership at the club where he is an employee. Councillor Harding has no specific interest in the matter other than his function of being a Councillor and more importantly there is no monetary interest.

Therefore I make the following recommendation concerning Councillor Harding:

2018-178 Resolved that Council finds Councillor Harding is not in Conflict of Interest for matters he is voting on regarding a person that merely has a membership with the Murray's Pond Country Club and there is no monetary interest for Councillor Harding or Murray's Pond Country Club.

Note: Councillor Hanlon noted that the election of Board members are nominated from the membership, who in turn set salaries and that might cause conflict but Councillor Harding explained to Council that his wage contract is set in place for the next 4 ½ years and when the Board election time is drawing near, it is his responsibility to check the approval verses nominee history for possible conflict.

This amendment may also require an amendment to the St. John's Urban Region Regional Plan.

Note: Councillor Hanlon clarified that Ridge Road is currently known up closer to Witch Hazel road but originally Ridge Road was just up from the path to Beachy Cove Beach. This amendment will take in the Thornes property and the beach area to show which should have always been in the traditional community.

7. Proposed Amendment to Increase Maximum Cul-de-Sac Lengths

As a result of discussions held at the Committee meeting, the Committee is requesting that the Notice of Motion presented at the May 29, 2018 Council meeting be amended to reflect an increase the maximum street length of fully-serviced, semi-serviced, and unserviced streets from 300 m to 450 m at its furthest point as opposed to the 409 m identified on May 29.

Therefore, please accept this notice that a motion will be presented at the June 26, 2018 public Council meeting to complete an amendment to Development Regulation 90 (c) (Subdivision Design Standards) within the Town's Development Regulations 2014-2024 to increase the maximum street length of fully-serviced, semi-serviced, and unserviced streets from 300 m to 450 m at its furthest point.

3. **Ride for Dad**

The route will begin in the City of St. John's, travel down Thorburn Road, up Tuckers Hill Road, onto Beachy Cove Road and Portugal Cove Road. It will turn onto Old Broad Cove Road and then onto Bennett's Road and back out Thorburn Road. The ride will be in our community for approximately a half hour and they will be escorted by the RNC. All traffic concerns will be address by the RNC as they travel along the route. The Director of EDCM has been notified of the event and he has ensured that residents will be notified.

The Canada Day and Regatta Festival will be taking place from Saturday, June 30th to Saturday, July 7th. The advertising brochures has been sent to print and are scheduled for delivery on June 15th. They will be distributed in the mail at that time. The full schedule is currently available on the Town's website. The Town would like to invite residents to practice rowing before Regatta Day. This will give those who have not had experience of being in a dory, the opportunity to try. Notification will be placed on social media and the website of times and location once it has been determined.

Public Works Committee Report for June 6, 2018 – presented by Councillor Laham

1. Retirement of Municipal General Maintenance Worker

Staff advised that a longtime employee of the Town as tendered his resignation effective June 15, 2018. This is a fulltime permanent position which will require immediate replacement and will be posted as per the Collective Agreement.

2. Blind Hill Sign Request

Staff were advised that a request was made to install a blind hill sign on Beachy Cove Road near the Beachy Cove Café. As this area is under the jurisdiction of Transportation and Works, the request will be forwarded onto them for consideration.

3. Pedestrian Activate Crosswalk Lighting

Committee requested that staff contact the Department of Transportation and Work to request the installation of pedestrian activated crosswalk lighting on Thorburn Road in the area of Brookside Intermediate School. Staff will bring response back to future committee meeting.

4. Netherwood Street Lighting

Deferred to next Committee meeting.

5. Western Gully Road Culvert

Public Works sent an email request to the Department of Transportation and Works on September 15, 2015 requesting that the culvert and ditch on Portugal Cove Road at Western Gully Road was in need of repair. To date repairs have not been initiated and due to the current state of the culvert staff are seeking approval to undertake the repairs.

2018-193 Resolved that undertaking necessary repairs to the culvert at Portugal Cove Road and Western

Gully Road by the Town's Public Works Division be approved.

Note: Staff have identified that this is a safety issue for large vehicles while turning. Transportation and Works has not corrected the issue so committee is asking to do the work (the new culvert has been in our depot yard for 3 years) and send the bill to Transportation and Works after repairs are complete.

6. Cross Culvert - Portugal Cove Road / Old Cart Road

No update to report. Mayor McDonald will reach out to the Minister of Transportation and Works on this matter.

Note: The foreman of Public Works monitored the issue and said there was 4 inches running over the wall but didn't make it to the next culvert because of the dry ground.

7. Beachy Cove Road – Report following Rainstorm

Transportation and Works expediently made repairs to the roadway and shoulder of Beachy Cove Road following significant damage during the May 30th rainstorm.

8. Culverts – Bayview Heights, Mercers Road and Ayres Lane

A request to conduct assessments for culvert replacements in these areas was put forward. Bayview Heights and Mercers Road are Town maintained roads therefore these will be assessed. Ayres Lane is a privately maintained road, therefore an assessment will be completed with findings brought back to future Committee meeting.

9. Speed Hump Request – Dogberry Hill Road Ext.

Request to install a speed hump on Dogberry Hill Road Ext. was put forward. The complaint will be referred through the Town's Traffic Calming Policy.

10. Newbury Street Speed Limit

Councillor Harding put forward a Motion to Committee to reduce the speed limit on Newbury Street from 50kms/hr to 40kms/hr; the Motion was not seconded therefore speed limit will remain.

Councillor Stewart Sharpe requested the committee review this item again. It was noted that the street had a traffic calming study done on the 50 kms/hr speed limit. Deputy Mayor Laham said the speed limit is in line with the current policy. The PCSP Speed Limit Policy will be reviewed by the Public Works department for the sake of safety on all roads and consistency throughout the town.

11. 27 Emberlys Road

Quotes for installation of a fence and cost to change embankment slope adjacent to 27 Emberlys Road have been obtained in the amounts of \$2,169 plus HST and \$1,935 plus HST.

<u>Economic Development, Marketing, Communications & Tourism Committee for June 6, 2018 – presented by Councillor Neary</u>

1. Heritage Updates

The Town has been invited to speak at the Wooden Boat Museum AGM in Twillingate on September 28-29. The Fanny Goff Memorial will be officially opened on Thursday, June 14.

2. Environment Updates

The Community Clean Up had mixed results this year. Unfortunately, the 10 day period that it occurred over had poor weather. Despite good uptake on social media before the event the number of participants were lower than expected. We would like to thank all those who did get out and our wonderful partners Murrays Garden and Horticultural Services. We look forward to growing the event next year.

Note: Councillor Hanlon asked to extend the Community Clean Up all year long which may help to work around the weather. Suggested we leave the garbage bags and gloves out for residents all year long. It was agreed that clean up should be a longer period, promoted in a way that will be accommodating to everyone next year. Councillor Harding asked committee to think about tying the event into a bulk garbage day or dangerous goods day.

The Stewardship Association of Municipalities sent correspondence to all members asking if a Town representative could attend their Fall meeting in Labrador this September and have asked which dates would work best. Attendance of the meeting will include a travel subsidy of approximately \$700. A response letter will be drafted indicating the dates that would be preferred.

The Climate Change Adaption Project's first workshop is scheduled for Monday, June 11th and have over 30 confirmed participants.

3. Chamber of Commerce

A meeting is scheduled with the Advisory Committees on Wednesday, June 6 to discuss a tourism development plan and open a dialogue of collaboration. The Chamber is hosting a Barn Dance on Saturday, June 16 for their members where the Business Directory will be launched.

4. Media Training

Further to the proposal considered at the prior committee meeting, additional information regarding an interactive workshop for Council and media training was reviewed. The workshop will include training on social media, best practices and help establish communications protocols for Council and staff. To support the training, interviews will occur with Council and senior staff

to better understand the issues and opportunities that Council face and will help customize the workshop.

A draft of the City of St. John's signage proposal was reviewed by the committee. This piece of work includes the regional component of the hub and spoke design and implementation. The proposal is currently being considered and negotiated with funding partners prior to any commitments or decisions by the Town. A proposal for PCSP specific signs is currently under development and will be submitted in the next month.

6. Portugal Cove Lookout

Feedback has been provided by Council on issues and ideas around a potential lookout. The Planning and Development Department is researching land ownership in the area.

7. Service Level Review

An overview of the Phase III report was presented to the committee. It will be submitted to council for their review and feedback.

8. Tourism Opportunity

A meeting with a potential tourism operator and a number of stakeholders took place on Tuesday, June 5th. A presentation to Council is being planned.

1. Traffic Concerns and Motorized Vehicles on Mitchel's Pond

A resident spoke with the Director of Recreation and Community Services regarding their concerns with vehicles parking on the side of Bennet's Road impeding traffic. They also expressed concerns with sea-dooing on the pond. Committee was aware of this issue and it was being addressed through the Public Works Department. An email was sent out to the Department of Transportation and works to which staff was waiting for a reply. A follow up email will be sent that it will be brought back to the Public Works Committee for further discussion.

2. Green Space on Bauline Line Ext

A resident of the community is interested in donating a piece of property on Bauline line that is in near Voisey's Brook Park. Staff will obtain more information on the property and bring the information back to committee for discussion.

3. Lifestyle Centre

On Tuesday, July 12th the Recreation Committee met with the Chamber of Commerce Steering Committee (COC) to discuss the Lifestyle Centre. The COC made recommendations for Council to consider and the Recreation Committee discussed those in length. One of the concerns from the discussions was regarding the Town leasing, owning, or renting space out to business/public in the Lifestyle Centre. Please find attached information in the Municipal Act regarding this issue.

4. Summerwood Playground

As Council is aware, residents in the Thorburn Woods Subdivision have been fund-raising to help support the upgrade of the playground on Summerwood Drive. As well the PCSP Lion's Club has confirmed their support to purchase the inclusion swing. The Town has allocated funding in the budget to complete this project and can collect the supporting funds from the groups once the project has been completed. The Committee would like to make the following recommendation:

MOTION: Committee recommends that the Town contact Grand Concourse Authority to upgrade Thorburn Road Playground to include an inclusion swing and rubber safety surface in the amount of \$106,885.52.

5. Older Adult Fitness Class

The Recreation Committee discussed the Older Adult Fitness Class that the Programs Coordinator is currently running. Although this program is very successful it is recommended that staff look into the interest level from seniors in a "low impact" fitness class. Details of the program will be developed over the summer and if enough interest is generated, a class will be introduced in September.

6. Field Rental Rates


With the expansion of the softball fields, minor softball teams from outside the committee have expressed interested in renting the facilities. For this reason the Committee would like to make the following recommendation:

Property acquisition

- **201.** (1) A council may acquire and hold real and personal property which is not necessary for the operations of the council under this Act.
- (2) Notwithstanding subsection (1), a council shall not acquire and hold real and personal property under that subsection without the prior written approval of the minister.

Sale or lease of property valued at \$500 or more

- 201.2 (1) This section only applies to real or personal property with an estimated fair market value of \$500 or more.
 - (2) A council may by resolution sell or lease real or personal property.
 - (3) A council shall give public notice of the council's intention to sell or lease real or personal property.
- (4) Public notice under subsection (3) shall include an advertisement in not fewer than 2 conspicuous places in the municipality and publication in a newspaper having general circulation in the municipality, where there is one.
- (5) A council shall only accept an offer to sell or lease real or personal property if that offer is the highest offer for the property.
- (6) Notwithstanding subsection (5), a council shall not accept an offer to sell or lease real or personal property that is less than the estimated fair market value.
- (7) Notwithstanding subsections (5) and (6), a council may, by resolution of 2/3 vote of the councillors in office and with the prior approval of the minister, accept an offer to sell or lease real property at less than the estimated fair market value, or accept an offer to sell or lease real property that is not the highest offer, where the purpose of the sale or lease is social or economic development.
- (8) Notwithstanding subsection (6), a council may, by resolution of 2/3 vote of the councillors in office and with the prior approval of the minister, accept an offer to sell real property at less than the estimated fair market value where the sale is to the owner of adjacent real property and the real property is of minimal value to another person.

Previous Committee report indicated that quotes for installation of a fence and cost to change embankment slope adjacent to 27 Emberlys Road were obtained in the amounts of \$2,169 plus HST and \$1,935 plus HST. A correction is required as the quotes are for the installation of the fencing portion only.

MOTION: Committee recommends installation of the fence adjacent to 27 Emberlys Road by Apex Construction Specialties Inc. at a cost of \$1,935.00 plus HST.

Discussion Items

5. Update on Transportation and Works (TW) Outstanding Items

a) Pedestrian Activated Crosswalk Lighting

Correspondence will be sent to request the installation of pedestrian activated crosswalk lighting on Thorburn Road in the area of Brookside Intermediate School. Staff will bring the response back to future committee meeting.



b) Western Gully Road Culvert

Public Works will undertake the required work to replace the culvert at the bottom of Western Gully Road; as this intersects with Portugal Cove Road, a permit from Transportation and Works is required. Request for same has been sent to TW.

c) Portugal Cove Road Cross-Culvert

Site visit has been completed with the Town Manager, Public Works Foreman and Superintendent of Operations (TW) in attendance; follow up correspondence will be sent to TW and they will provide a response. Once received, update will be brought to future Committee meeting.

d) Intersection of Tuckers Hill and Thorburn Road

Councillor Harding made a motion to request that Transportation and Works reconfigure this intersection into a three-way stop. Motion was not supported by Committee. While a long term solution may need to be identified, in the interim, correspondence will be sent to Transportation and Works requesting that they recommend a short-term solution.

e) Signage Request on Transportation and Works Roads

Request for the following signs to be sent to TW: Beachy Cove Road – Blind Turn; Beachy Cove Road and West Point – Sharp Turn Ahead; Portugal Cove Road – Hidden Driveway; and Portugal Cove Road at Anglican Cemetery Road – Left Turning Traffic Ahead.

6. Thorburn Road – Parking Issues

Concerns have been identified on Thorburn Road with respect to vehicles parking on Crown Land. The Town Manager will contact them to discuss the matter and as well will contact Transportation and Works to present a solution.

7. Business Signage

The issue of business signage was discussed. Public Works will endeavor to propose a Road Sign Policy and present at future Committee meeting.

8. Hazardous Waste Collection

Staff will contact the City of St. John's to inquire what steps would need to be taken and determine what costs would be associated with the Town holding a hazardous waste collection day.

9. Western Gully Road – Water Run-off

An assessment was conducted on Western Gully Road in an area where concerns about water run-off were suggested. It has been determined that the run off is very minimal and would not warrant undertaking any changes.

10. Netherwood Street Lighting

This matter is under review and until completion of same, will be deferred.

11. Sidewalk Installations – Megan Ridge

Discussion held on the progress of sidewalk installations and corresponding work.

1. Commissionaires - Municipal Enforcement

The Municipal Enforcement Officer offered the following update on activity since the last Committee meeting:

- MEO has completed Animal Protection training and is only waiting on the completion certificate to be able to issue tickets for related offences.
- Attended meeting at RNC headquarters with resident Pat Pender, Chief Joe Boland, and Inspector Eddie Oates. The meeting revolved around speeding traffic concerns and RNC presence in the community. Mr. Pender was requesting more enforcement of Old Broad Cove Road.
- 109 Dogberry Hill Road investigated reports that rats were tearing up garbage and found that rats were living and nesting under the house. No other neighbours had issues.
- Evening patrols have been adjusted to new schedule and are leading to more community engagement and communication. They are having a positive effect throughout the community.
- Evening patrols reported a dirt bike driver to RNC for stunt driving and dangerous driving, MEO was able to locate driver's home address and RNC met with parents of the driver. Evening patrols also reported a suspected impaired driver to RNC for investigation.
- MEO investigated Farm Road complaint and made contact with owner and invited resident to speak with Planning & Development Department on what needs to be done to resolve the issue.

Ongoing:

- Civic numbering audit is moving along and door knockers are being issued for any property's found in non-compliance. Door knockers provide home owners with basic information on how to become compliant.




To Whom it may concern:

I send this letter to express my concerns about the constant speeding near my home on Old Broad Cove Road. My home is located near a road sign that displays the speed of vehicles as they pass and I regularly observe vehicles travelling more than 20 km/h over the speed limit – this often occurs while I wait for the school bus with my children. Unfortunately, with such recklessness, we must avoid travelling our road by foot and cannot let our children play in the front yard without constant supervision.

There have been a few instances this year where we have seen the presence of RNC officers in the area (September and April) and it greatly reduced the speed of travelers in the area while the units were present. However, it has been months since we have seen any officers to address speeding in our area.

With the return of nicer weather, I am certain that the speeds in our neighborhood will only increase, as we have noticed in previous years. I hope that with these meetings, the RNC can endeavor to have more presence in our neighborhood in the hopes of reducing speeding and increasing safety for our community.

To Whom It May Concern

I am writing to express my concern with dangerous driving on Old Broad Cove Road.

In recent years traffic volume has significantly increased in my neighbourhood. Unfortunately the level of aggressive driving has increased right along with it. I have had many close calls pulling out of my driveway and a couple years ago my neighbour was hit while pulling out of his driveway. Hit by a lunatic travelling at speed exceeding 100 km/hr. The collision caused \$15000.00 damage to my neighbour's truck. It's amazing that nobody was killed or seriously injured. We measured a skid mark that was more than 90 feet long.

Last summer I decided to start riding my bicycle again to try and get fit. I rode to the store and back and that was enough for me. The speeding lunatics screaming' past me like scalded cats gave me such a fright that I will not ride on my street again.

During the winter months when snow banks are alongside the road, I have to hike through the woods to walk to the mail box, because it is simply too dangerous to walk along the side of the road.

All day long vehicles pass my home at 60 to 80 km/hr in a 40 zone. If I am driving at or even slightly above the posted speed limit. A line of traffic will form behind me and often they will pass me on a blind turn with a solid line. While giving me the royal salute as they pass. If law enforcement would dedicate more resources to patrolling this area, the Justice Department would make enough revenues in fines to pay for more patrol cars and constables to patrol in them.

It is my sincere hope that something is done to resolve this extremely dangerous situation before somebody's child is killed by these ignorant monkeys that continue to terrorize my neighbourhood.

I have been a resident of Old Broad Cove Road for 43 years. I have witnessed changes in our neighborhood i.e. subdivisions have been developed. And this increase in housing has brought young families and children to our area. With the rise in population, we have seen an increase in traffic. And speeding has become a grave concern for all the residents in our neighborhood. There are dirt bikes and quads illegally driving on our roads in a reckless manner. Vehicles exceeding the speed limit. Speeds of 40 to 50 kmh are acceptable; however, we are seeing speeds up to 70 an 80 kmh which shows a total disregard for the rules of the road.

Young families walking with their children or pushing a stroller are in peril of being knocked down by these speeding vehicles. Couples out for a walk or people walking their dog are also taking a huge risk.

As a growing area, this community must learn that these high speeds are totally unacceptable. A plan has to be put in place to achieve this goal. The electronic speed sign has certainly helped me to be more attentive. Maybe there are other measures that can be used: speed bumps, surveillance, ticketing and a traffic calming neighborhood.

I sincerely hope that some of my concerns will be addressed.

Dear Chief Joe Boland,

I am writing this letter as a concerned resident of the town of Portugal Cove-St. Philips. I have lived at Cold Broad Cove Road for 9 years, and during that time I have seen a significant increase in the volume of traffic. With such an increase of traffic one would think that speeds along this road would reduce. Needless to say, the exact opposite has happened! On countless occasions over the years, I have witness vehicles pass along my home at speeds in excess of 100 kilometers an hour, in a 40-kilometer zone! I have also witnessed impatient drivers passing law abiding citizens along this stretch of road. I have seen too many examples of these situations and we need a change!

As a father of two, I am quite aware of the risks that this road presents. As my kids have grown I have had to implement my own methods of safe play. After a school bus was rearended in front of my home while my kids were getting on, we are very concerned of the speeds and safety of the children in this neighborhood. I always place signage at the bottom of my driveway, I have tied a rope with florescent ribbon across the driveway, and as a third precaution, I put my own vehicles perpendicular to my driveway. You may think overkill, I think of it as prevention of being killed. Cars, trucks, motorcycles, dump trucks, ATVs, and dirt bikes all abuse the posted speed limit. With numerous turns and hidden driveways, it is only a matter of time that tragedy will strike!

I would also like to add that Old Broad Cove Road is often used by cyclists, runners, and walkers. I pay a very material amount of money in town taxes. For the money paid in 9 years I have seen no safety measures implemented along this road. So, it goes without saying that

this road has been grossly ignored. We desperately need sidewalks and more police enforcement!!

I hope this summarizes my concerns and issues with pedestrian safety. I hope you have an opportunity to listen to my concerns and begin the process of creating a safe and caring community.

To Whom It May Concern,

Back in the fall and once again in April I wrote a letter to the Town of Portugal Cove-St. Philip's, expressing concern about the excessive speeds and safety of residents on Old Broad Cove Road in the area of Sparta Place just down from Maggie's Place. I am following up with this letter because the speeds are still high and vehicles are still passing one another along that straight stretch of road.

I am currently a stay-at-home Mom so I spend a lot of time outside with my children and visually see the speeds on the sign as the sign is right across the road from our home. I am out with my oldest child in the mornings waiting for her bus to Beachy Cove and outside throughout the day with my youngest, going for walks or using his bikes, etc in our yard. Then we are outside waiting for the safe return of my oldest child on her bus.

While waiting for the bus in the mornings I've noticed that most speeds are over 60km/hr. I've seen them beginning at 78 km/hr and because I walk out a little into the road and point at the sign they slow down a little, but never to 40km/hr which is the posted speed for this area. This is not counting the vehicles traveling on the opposite side of the road; where there is no speed sign to show how fast they are going.

Summer is coming and something has to be done! Safety should be #1 for the residents in our community! I fear for my children and other's in our area. There should be no reason why people in this area cannot walk to the mailboxes without fearing they may be hit by a passing car that is driving at such excessive speeds.

I have to commend the RNC for their efforts with speeding in our area. I have seen them doing radar just up from our house and have done a great job catching some of the excessive speeders. Patrol cars by the RNC have been seen from time to time in the area, but the speeds are still excessive. I do understand that the RNC can only be in this area from time to time, so why can't there be something else to deter the people from speeding along this area? Why can't some speed humps be installed over the spring/summer season? I can understand in the winter when snow clearing is an issue, but maybe for the safety of residents you could consider this as a trial.

Some examples that I've seen lately in the area;

There is a piece of land across the road from our house for sale and it's where the speed sign is located. A car was pulled off on the side of the road (near our driveway) and the man was out of his car taking down the information and contact number regarding the piece of land. A car drove by very fast and basically flew pass the man as he was stood there trying to write down the information. The vehicle did not pull over into the other lane, but was very close to that man.

- A red truck with white writing over its tinted windows speeding pass our house around 6:30 a couple of nights now. We were out with the children and my husband actually took note of it and yelled at the truck "slow down". Obviously the truck driver did not care and went on his merrily way, but it's frustrating for residents, especially knowing our children are out there playing.
- Waiting for the bus at 2:30-3:05 on a Monday and there were speeds of 74 and 76km/hr flying down over the hill and they don't slow down until they have to go around the turn further down the road. There were also numerous vehicle's travelling above 60 km/hr as well. I could count on one hand how many were driving at a decent speed (below 55 km/hr).
- April 17 I noticed the grey ghost RNC patrol car on our street in the morning, and then when I was walking my daughter across the road from our home to the bus, there was another RNC white patrol car a couple of vehicles behind the bus. I do commend the RNC for their efforts and driving in our area.

I know I am not the only person in this area concerned about the excessive speeds. I feel that I should take the time to once again express my concern for the safety of the residents in this area of Portugal Cove-St. Philip's and hope that something can be done to assist with this. We've done the signage on our lawns, we put out our own "SLOW" sign when the kid's are at play, but there has to be some other approach because none of this is working with the excessive speeding. You have to understand that I would never want to have to have my child or someone else's hit by a car.

Councillor Hanlon/Chief Boland,

I moved to Portugal Cove in 2011, to settle into a home and town that provide me space and a relaxing environment.

In the past couple of years, my wife and I have noticed the increase in traffic volume travelling on Old Broadcove Road. We have also noticed that most of the traffic passing our place seemed to be travelling in excess of the posted speed limit (40 km/hr). This is concerning for us as there are many children in the homes that surround our place. These children are walking on the main road when going to each other homes to play.

I am now walking my puppies 2 hours every morning and 1 hour every evening. Monday to Friday, for my walks in the morning, I leave my home around 4 am. There are several routes that I take covering Old Broadcove Road, Witch Hazel Road, Bennett's Road, Oliver's Pond Road and Portugal Cove Road. When I am walking my dogs, I am wearing my vest and head lamp to ensure that I am seen by road traffic.

Normally, during my walks, I start encountering traffic around 5 am. Most of the vehicles that I encounter, from my assessment, are travelling above the speed limit. When they see me, some do slow down and move over (if possible) when they pass. However, there are the vehicles that don't slow down. They do move over, but continue to speed. I can always tell when the ferry has landed in the cove as most of the vehicles leaving the ferry and travel towards town are speeding.

I realize that, with respect to speeding, we are not going to get 100% compliance. At the last meeting, the RNC officer handed around speed data collected which they had done averages of the speed for vehicle traffic. The data presented, someone not living on Old Broadcove Road would be lead to believe that there is no speeding issue. We know that there is an issue with speeding and as the weather warms up, the problem is going to get worse.


As I mentioned earlier, I walk between 10-12 km everyday exercising my dogs. Anyone who has travelled Old Broad Cove Road, Portugal Cove Road, Bennett's Road, etc. can attests to the poor condition of these roads. Not only are the paved surfaces of these roads in very poor condition, but the dirt shoulders of the roads are also in poor condition. There are deep ruts, narrow sections and pot holes on the shoulders that make walking on the shoulder only difficult. This is especially evident on Old Broadcove Road, going along Windsor Lake section.

When I leave my home to go for my walk, it is dark and my headlamp only shows a small area. Thus, when I am travelling the roads, I am also walking on the pavement, not the dirt shoulder. When I see traffic coming my way, I do move of to the shoulder and I stand shining my light onto my dogs. This way the driver sees everything. There are sections where I can't get totally of the road, but I am as close to the shoulder as possible. I take as many precautions as I can, and over the past 7 months, I have had several incidents which were too close for my comfort.

The combination I described above will lead to someone getting hurt and at the speeds vehicles & motor cycles are travelling, it is more likely that the injury will be very serious. I know the police can not be in area all the time, but we do need a greater police presence. The technology is out there to identify when there is highest traffic flow and more likely more speeding. I know if you parked by the Tilt House Bakery between 5 & 6 am, you will get speeders coming of the ferry.

Do I want people to get tickets? If that is what it takes to ensure my safety when I am walking and the safety of my neighbours, then so be it. However, having more frequent patrols by the police in the area will make drivers more conscious of their speed. Also, repairs to the road shoulders will allow pedestrians space to travel safely on our busy streets.

To all Mayors and councils:

Re: Cross-country consultations on air passenger rights and the aviation ecosystem

As a mayor and municipal leader, you understand better than most the importance of safe, efficient and economical transportation to your community and to Canada. With the Canadian Transportation Agency (CTA) holding public consultations on a new passenger rights regime, I want to enlist your support to ensure that these hearings contribute to an improved, more competitive air passenger transportation system.

Every day in Canada, some 350,000 air travellers have safe and uneventful flights. Thousands of people in many organizations including airlines, airports, air traffic control, and government agencies responsible for border control, security, customs and immigration contribute to the success of every flight.

But for those air travellers, most of these interactions occur behind the scenes. Which is why it is not surprising that when something goes awry, responsibility is often assigned to the most visible player—the air carrier. There is little

discussion of the role played by others involved in their flight or the impact of external forces, such as weather or distant ground stops.

Commercial aviation is highly complex anywhere. Canada's operating environment, including climate, geography and population distribution requires an exceedingly high level of coordination and operational sophistication. Adding to the cost and complexity of commercial aviation in this country are federal policies that make it increasingly difficult for our air transport system to remain globally competitive.

Together, these thousands of people, dozens of organizations along with our policy and regulatory environment make up Canada's aviation ecosystem.

Attempts to improve passenger air travel through government regulation must look at the ecosystem as whole.

For example, system-wide capacity issues are caused by labour and other shortages in our partner organizations and government agencies. The Canadian Air Transport Security Authority (CATSA) and the Canada Border Services Agency (CBSA) have stagnant budgets with which to manage growing responsibilities.

Airport infrastructure dictates many aspects of airline operations, as do government regulations. For example, de-icing regulations, essential as they are, can lead to tarmac delays because of capacity issues. Canada's climate and challenging weather conditions, which are in no one's control, can disrupt airline scheduling.

Focusing solely on airlines and developing a punitive system to enforce new regulations, while easy, may well fail to deliver the travel experience Canadian air passengers want and deserve. Consider the experience of the United States, where harsh regulations fining airlines for tarmac delays seem to have backfired.

According to a study by Dartmouth College and the Massachusetts Institute of Technology, the regulations have "significantly increased" the number of passenger delays, with each minute of time saved waiting on the tarmac translating into roughly three minutes of total passenger delay.

This is due primarily to increases in flight cancellations, resulting in passengers needing to rebook and often leading to extensive delays in reaching their final destination. Such an unanticipated outcome in Canada would be particularly challenging for northern, remote and Atlantic communities, which are more vulnerable to weather-related events.

This example points to the need for a balanced and holistic approach that recognizes operational and safety realities and encourages system-wide improvements in capacity and operations, including security, border screening, air traffic control and airport infrastructure.

We have created a video (see below) to explain the complexity of the commercial aviation ecosystem and why every policy that affects aviation must recognize that ecosystem and ensure better coordination, greater synergies and more collective accountability among its members.

We encourage you to share the video with your council colleagues, staff and constituents. We also encourage you to advocate to the CTA and the Minister of Transport for an approach to passenger rights that recognizes the complexity of the aviation system and Canada's unique operating environment.

Our member airlines want to work with you and your communities to make passenger air travel in Canada better for everyone. No one will benefit from a simplistic approach that creates unintended consequences that hurt the people they intended to help.





Backgrounder: The Aviation Ecosystem.

The international experience tells us that attempts to improve passenger air travel must look at the ecosystem as whole. For example, US tarmac delay rules with their highly punitive monectary administrate penalities have resulted in a reduction in tarmac delays, but an increase in flight cancellations and in overall in transit time for passengers¹.

Prescriptions for change developed without considering the entire system risk unintended consequences, including new costs for travellers.


